

# Universal Law VIOLATION CITATION

## *Notice of Liability*

### **Receipt of this Notice requires by law that the recipient:**

- 1.) CEASE AND DESIST the harmful activities that comprise the crimes against humanity, and:
- 2.) Assume *responsibility to TAKE ACTION* to rectify the situation, reverse the destructive actions and measures, retract and correct harmful actions and false communications, laws or regulations, and provide restitution commensurate with your personal complicity in these crimes.

### **CITATION OF LAWS VIOLATED:**

- 1.) Abuse of power; usurping power that was never authorized
- 2.) Stepping out of jurisdictional boundaries
- 3.) Intent to override the conscience of sovereign beings
- 4.) The use of deception to override free will choice and the consent of sovereign beings
- 5.) Manufacturing and implementing plans and agendas that are harming the human population
- 6.) Thievery of natural resources; hoarding supplies; acquisition through the darkness of secrets and lies to cover up such treasonous activities
- 7.) Harvesting of human energy through systems of deception and infiltration of institutions that were created to promote human welfare
